Our outstanding exhibitions and learning activities are free to all. Join our new membership scheme and get close to your favourite museums and support our important work.

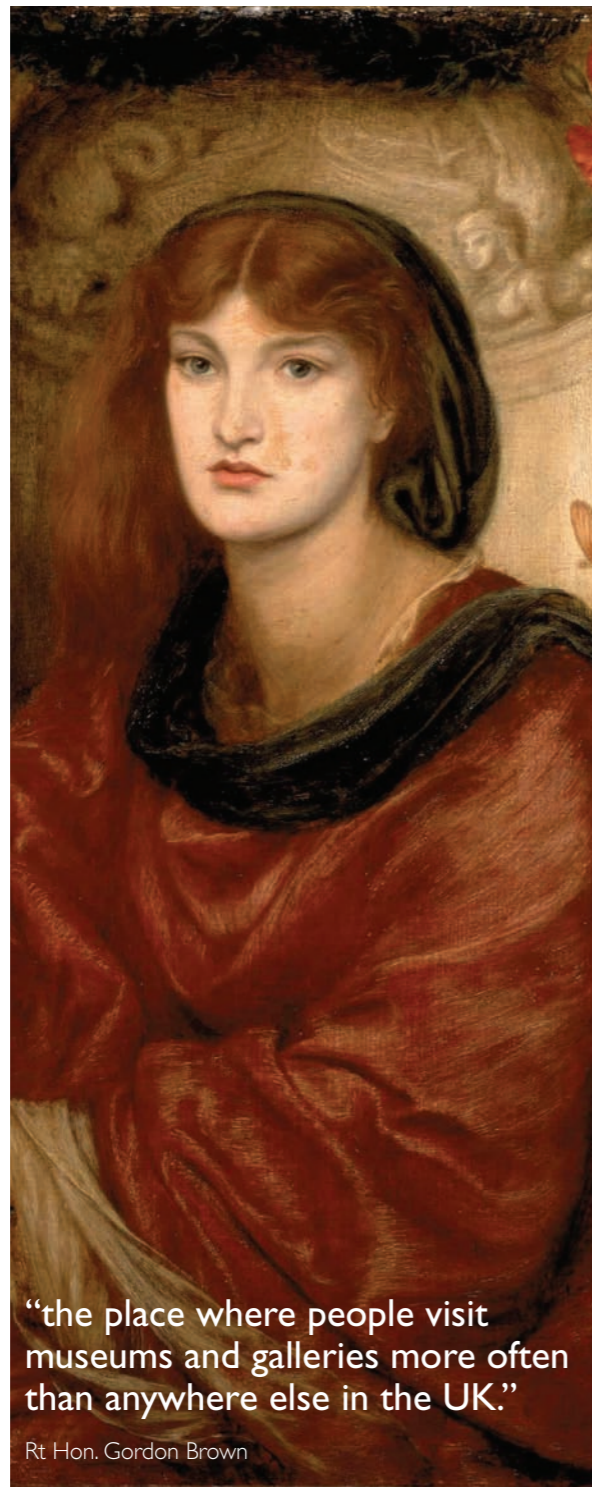
